Privacy Policy

The websites – 'AgriCycle.in' ("Websites") is owned and operated by Maneru AgriCycle Private Limited ("We", "Us", "Company" or "Our", which expression shall mean and include its affiliates, successors and assigns). We are committed to protecting and respecting Your privacy.

This policy describes our policies and procedures for collection, use, storage, disclosure and protection of any information, including, but not limited to, business or personal information provided by you ("you/r") while using the website.

This policy constitutes a legal agreement between you, as the user of the website, and the company, as the owner of the website. by voluntarily providing us with information, you are consenting to the company's use of it in accordance with this policy. by merely visiting/ accessing the website, you expressly consent to the company's use and disclosure of your personal information in accordance with this privacy policy. This policy does not apply to third-party websites that are connected via links to the website. If you do not agree with the terms and conditions of this policy, please do not proceed further to use/ access this website in any way or download the app. also in the absence of an acceptance of the policy by you, we will not be able to provide the services or products to you.

This policy has been drafted in accordance with the information technology act, 2000 and the data protection rules and regulations of india.

1. Information Collected

We will use the information provided by You only in accordance with the purposes described in the Policy.

We collect Your Personal Information or Non Personal Information (as hereinafter defined) when You download and use the Websites and at the time of Your registration with the Websites. Further, We collect information from You during the performance of Services for You. We collect information with respect to Your name, mobile number, email, address, IP Address, zip code, age, gender, occupation, Your location, device ID, Device location, other related things like crops grown, crops to check prices for, products interested in, articles and posts liked etc. In addition to the foregoing, We also access Your contacts on Your mobile phone and Your SMSs. We also gain the ability to write to the external memory on Your mobile phone. We collect all of the foregoing information in order to provide You the Services.

During Your use of the Websites, We may collect and process such information from You, including but not limited to the below mentioned:

(a) Personal Information:

"Personal Information" means and includes:

(a) Information that You provide to Us by filling in forms on the Websites.
